

Hey! Mr. FEMA Gyani. I heard that RBI has recently introduced a portal where we can submit our applications. Is it really so?

Hii Nikhil. Yes RBI has introduced a single portal named **PRAVAAH** (https://pravaah.rbi.org.in.) to seek authorization, license or regulatory approval on any reference made to the Reserve Bank.






Who all can submit their applications on this portal?



The intended audience for this portal are **Citizens** and **Business entities/external parties.**





At present, **60 application forms** covering different regulatory and supervisory departments of RBI have been made available on the portal.



Do we have to get registered on the portal first and what all information is required for the registration process?

Users are required to provide **basic details** on the portal before submitting an application/request. On entering the basic details including the mobile number, the **users can login after verification of OTP sent on their mobile number.**

Please note that the **mobile number is the unique identifier**, which is to be used to **access the portal**, submit applications, submit additional information, download documents, view application history etc.

Let me brief you about the forms that can be submitted to RBI under FEMA.



The following forms are included under FEMA

Approval for Opening of Special Rupee Vostro Account 2

Regulatory Approvals pertaining to LO or BO or PO in India

3

Approval for Acquisition or Sale of Immovable Property 4

Regulatory Approvals under FEMA - five R and FEMA ten R 5

Approval for Bank Guarantees beyond limit available to AD Banks

6

ECB proposals under Approval route 7

Confirmation for appearing for personal hearing w.r.t. compounding proceedings along with preferred date, time or attending personnel information

8

Compounding application

9

Additional information or addendum to already filed compounding application
